Open Letter to DeKalb State Legislators:

DeKalb Citizens Advocacy Council (DCAC) is reaching out to you as our delegation members to express several areas of concern regarding HB 431(SPLOST) and its potential impacts for stakeholders.

The areas of concern for which we are requesting your assistance and consideration are: (1) lack of process transparency, (2) countywide project funding, (3) distribution of funds, (4) removal of restrictions, and (5) implications if HB 431 does not pass in this General Assembly session.

## 1. Lack of Transparency

A proposal of changes to HB 431 was submitted to the House Delegation on February 13, 2023, by CEO Michael Thurmond. This legislation has not been fully vetted, nor were opportunities provided for stakeholder input prior to its submission. In viewing the Board of Commissioners Special Called Meeting about SPLOST held on February 23, 2023, it is evident that even some members of the Board were neither aware nor included in the process prior to submission to the House Delegation. There has been no comprehensive annual reporting of projects (a sample for such a requested report is attached). What has been reported on the county's website is superficial and does not contain any project detail. Lack of transparency has resulted in confusion, misinformation, and an increased level of distrust among stakeholders.

Waiting until after the amendment is passed for the county to then speak to the public about how the SPLOST may (or may not) be allocated, does not constitute transparency on any level. The CEO is well aware of the fact that the SPLOST is highly likely to be approved by voters in a referendum no matter how the county proposes to spend their tax money between now and then, because it is still attached to the eHOST/tax freeze.

Recommendation: Amend HB 431 to include reporting requirement of previous SPLOST funds prior to allocation for any new projects

Recommendation: Amend legislation so that any projects from the initial SPLOST that are incomplete or not started are given priority over any new projects

Recommendation: Amend HB 431 to mandate the publishing of an annual report for each of the six years that SPLOST funding is used

## 2. Countywide Projects

Countywide projects should be given priority with the allocations off the top of projected revenues. If not, this financial burden will be borne solely by the unincorporated area of the county.

Recommendation: Amend the legislation to require allocations for countywide projects to be funded prior to any other fund distributions

Recommendation: Amend HB 431 to require a full accounting of the funding of projects

### 3. Distribution of funds (cities vs. county)

It is unclear as to the sources (other than the 2020 Census) used to determine the per capita basis distribution of funds.

Recommendation: Amend HB 431 language to clarify the sources used in determining per capita allocations

#### 4. Removal of Allocation Restrictions

Due to lack of public input or any knowledge of potential projects, there is a concern that removal of the current 85% (transportation and public safety) and 15% (capital improvement) caps will create an open checkbook to expend funds on anything, whether stakeholders desire it or not. It is unfortunate that the lack of transparency continues a sense of distrust between taxpayers and elected officials. It is a fact that cannot be ignored without some oversight protections in the legislation.

Recommendation: Amend HB 431 to include language that helps to manage project considerations should HB 431 be approved

## 5. Implications of Not Passing HB 431

Given the haste with which this legislation has proceeded, it is critical that the concerns expressed are addressed and properly vetted with stakeholders. Please explain implications of passing the current version of SPLOST legislation.

Recommendation: Explain any implications should HB 431 not pass the General Assembly this session

Recommendation: Renew the current SPLOST legislation and delay HB 431 until the 2024 General Assembly session to allow for a better assessment of HB 431

We are requesting your thoughtful consideration of our recommendations for HB 431 to ensure that there is accountability in the use of SPLOST funds to best meets the needs and desires of the taxpayers before asking for their support of a referendum. Thank you for your consideration of these issues.
